If you have Registered on or after 1/9/2023 you will receive this email shortly after Registering.

h. complete the survey and provide your contact details and hit the Submit button, and a message will appear saying "Thank you for completing the Survey".

i. you will receive an email confirming that your National Secure Your Home Day Survey has been received and your entry has been entered into the Prize Draw.

## PRIZES

## GENERAL
