### NATIONAL SECURE YOUR HOME DAY KIDS COLOURING COMPETITION

#### **TERMS AND CONDITIONS**

1. This competition (the "**Promotion**") is conducted by Neighbourhood Watch Australasia (the "**Promoter**"), ABN 66 626 788 252 of PO Box 64, Spring Hill QLD 4004.

2. Entry to the Promotion constitutes acceptance of these Terms and Conditions. By entering the Promotion, the entrant and their parents or guardians accept and acknowledge full responsibility for their decision to participate in the Promotion and to accept the Prize if they are the winner.

3. All entry instructions and Prize information published by the Promoter form part of these Terms and Conditions.

4. The Promotion is open to all residents of Australia, subject to age requirements as per Clause 6. The Promoter reserves the right to request any entrant to provide documentary evidence confirming their age. ### THE COMPETITION

6. Original Colouring Competition.

There are two categories:

Category A – Entrants six (6) years of age and under as at 31/10/2023.

Category B – Entrants seven (7) years of age and up to thirteen (13) years of age as at 31/10/2023.

#### HOW TO ENTER

- 7. To enter, each entrant must:

(vi) colour in this sheet.

c. Entries must be the original artwork of the entrant.

# PRIZES AWARDED – JUDGING OF ENTRIES
