

NATIONAL SECURE YOUR HOME DAY 'COMPLETE THE SURVEY FOR YOUR CHANCE TO WIN' PROMOTION

Neighbourhood Watch Australasia is hosting **National Secure Your Home Day on Saturday 28 and Sunday 29 September 2024** (the last weekend of September). This is a fantastic opportunity to review and improve your home's security.

TERMS AND CONDITIONS

1. This competition (the "**Promotion**") is conducted by Neighbourhood Watch Australasia (the "**Promoter**"), ABN 66 626 788 252 of PO Box 64, Spring Hill QLD 4004.
2. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions.
3. Entry is only open to Australian residents aged 18 years or over. Employees (and their immediate families) of the Promoter, and participating agencies associated with this Promotion are ineligible to enter.
4. Promotion commences at 9:00 AM AEST on 12/8/2024 and ends at 11:59 PM AEST on 31/10/2024 ("**Promotional Period**").

HOW TO ENTER

5. To be eligible to enter individuals must
 - a. go online to the Homepage for National Secure Your Home Day website at www.secureyourhomeday.com.au
 - b. Scroll down to the Registration Form on the Homepage
OR
click on the "Register" menu tab at the top of the page
 - c. fully complete the required Registration Form details
 - d. when complete, click on "Register Now" to submit your registration
 - e. a message will appear saying "Thank you for registering for National Secure Your Home Day"
 - f. individuals who register prior to 1/9/2024 will receive a "Thank You for Registering" email, confirming your registration has been received
 - g. individuals who register between 1/9/2024 and 31/10/2024 will receive a "Your National Secure Your Home Day Kit" email, confirming your registration has been received
 - h. to finalise your entry into the Promotion, registered individuals must complete the National Secure Your Home Day 2024 Survey (the "**Survey**"). A link to the Survey will

be distributed by email to all registered individuals between 1/9/2024 and 31/10/2024;

- a. on 1/9/2024 to all existing registered individuals as at that date, or;
 - b. on the day of registering, for individuals who register after 1/9/2024 up until and including 31/10/2024
- i. the email containing the Survey link will have the subject line “Your National Secure Your Home Day Kit”. Subsequent Survey reminder emails may be sent to registered individuals by the Promoter, at the Promoters discretion
 - j. complete the survey and provide your contact details and press the Submit button, and a message will appear saying “Thank you for completing the Survey”
 - k. you will receive an email confirming that your National Secure Your Home Day Survey has been received and your entry has been entered into the Prize Draw
 - l. final Survey entries must be completed by 11:59 PM AEST on 31/10/2024. Survey entries submitted outside of the Promotional Period will not be eligible for the prize draw
 - m. if an individual has registered for National Secure Your Home Day prior to the Promotional Period, the individual does not need to register again. Existing registered individuals will receive the “Your National Secure Your Home Day Kit” email on 1/9/2024 which will include the Survey link, and the opportunity to enter the Promotion by way of completing the Survey
 - n. if an individual has registered for National Secure Your Home Day prior to the Promotional Period and has since unsubscribed from National Secure Your Home Day email communications, the individual is not considered to be registered for National Secure Your Home Day and must complete the entry process as outlined in clause 5 in order to participate in the Promotion

6. Only one (1) entry is permitted per entrant.

PRIZES

7. The first five (5) valid entries drawn will each win an Activ Visa Pre-Paid Gift Card to the value of \$100. The Activ Visa Gift Card can be used wherever pre-paid Visa is accepted. Gifts Cards are not transferrable for cash.

8. The prize will be provided to each winning entrant by Express Registered post.

9. A random prize draw will be conducted from all eligible entries received during the Promotional Period.

10. The draw will take place at the Promoter’s office, 7 Boundary Street, Brisbane QLD 4000 at 1:00 PM AEST on 14/11/2024. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn. Winners will be notified by email or phone within two (2) business days of the draw. Winner’s name and State/Territory will be announced online at National Secure Your Home Day (www.secureyourhomeday.com.au) and

Neighbourhood Watch Australasia (www.nhwa.com.au) from 20/11/2024. In the event of an SA winner, their name and State will also be announced in The Advertiser on 26/11/2024.

11. The first five (5) valid entries drawn from all entries received will each win an Activ Visa Pre-Paid Gift Card to the value of \$100.

GENERAL

12. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the Promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.

13. Incomplete or indecipherable entries will be deemed invalid.

14. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.

15. The Promoter's decision is final and no correspondence will be entered into.

16. Subject to the unclaimed prize draw, if for any reason the winner does not take or redeem a prize at or by the time stipulated by the Promoter, then the prize (or that element of the prize) will be forfeited.

17. Total prize pool value is \$500 (including GST). Any unused portion of a prize, are not transferable or exchangeable and cannot be taken as cash, unless otherwise specified.

18. A draw for any unclaimed prizes may take place on 13/2/2025 at the same time and place as the original draw, subject to any directions from a regulatory authority. For clarity, non-winners of the original draw, will be entered into the unclaimed prize draw. In the event of an SA winner, their name and State will also be announced in The Advertiser on 19/2/2025.

19. Entrants consent to the Promoter using their name, likeness, image and/or voice in the event they are a winner (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting this Promotion (including any outcome), and promoting any products manufactured, distributed and/or supplied by the Promoter.

20. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the Promotion, as appropriate.

21. Printing and other quality control errors will not invalidate an otherwise valid entry.

22. Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act (Cth), as well as any other implied warranties under the ASIC Act (Cth) or similar consumer protection laws in the States and Territories of Australia ("**Non-Excludable Guarantees**").

23. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of a prize.

24. As a condition of accepting a prize, the winner must sign any legal documentation as and in the form reasonably required by the Promoter.

25. The Promoter collects personal information ("PI") in order to conduct the Promotion and may, for this purpose, disclose such PI to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities. Entry is conditional on providing this PI. The Promoter will also use and handle PI as set out in its Privacy Policy, which can be viewed at www.secureyourhomeday.com.au/privacy-policy. The Privacy Policy also contains information about how entrants may opt out, access, update or correct their PI, how entrants may complain about a breach of the Australian Privacy Principles or any other applicable law and how those complaints will be dealt with.
